

Terms and conditions

- Information on how to enter form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry.
- The Promoters are AFT Pharmaceuticals Pty Ltd of 113 Wicks Road, North Ryde, NSW, 2113, ABN 29 105 636 413 and AFT Pharmaceuticals of Level 1, 129 Hurstmere Road, Takapuna, Auckland, 0622.
- The promotion commences on the 1st of September, 2023 and closes on the 31st of December, 2023 at 11.59pm (Promotional Period).
- To be eligible to enter, entrants must:
 - Be a resident of Australia or New Zealand; and
 - Be over 18 years of age; and
 - Be a retail customer and make a qualifying purchase of any Hemptuary product during the Promotional Period (Qualifying Purchase);
